Subject: Annual Performance Report for the Expenditure of Statewide RPO Planning Funds - Fiscal Year 2024-2025

Dear Mr. Raynor:

The Mid-East Rural Planning Organization (Mid-East RPO) continues to work in close partnership with our local government partners and the North Carolina Department of Transportation (NCDOT) in the cooperative, comprehensive, and continuing transportation planning process for our region and the state.

The Washington-Greenville Greenway Feasibility Study was officially completed in July 2024. The study, which was managed by the Mid-East RPO and conducted by McAdams, was made possible through State Planning & Research funds awarded by the NCDOT Transportation Planning Division. The recommendations of the study were endorsed by the Mid-East RPO Transportation Advisory Committee (TAC) in August 2024, and the Greenville Urban Area Metropolitan Planning Organization (Greenville Urban Area MPO) TAC in October 2024.

Work on the Mid-East RPO Comprehensive Safety Action Plan began in Spring 2025. The plan is a partnership between the Mid-East RPO and the NCDOT Traffic Safety Unit, and is being developed by Kittelson & Associates. The Comprehensive Safety Action Plan will play a key role in guiding our efforts to reduce serious injuries and fatalities on roadways in the Mid-East RPO region. RPO staff is anticipating the completion of the plan in early-2026.

The 15th Street Widening & Access Management Project (U-5860) drew closer to beginning right-of-way in FY 2024-2025. The project, which was funded in the STIP following its submittal in Prioritization 3.0, will enhance the safety and mobility of the 15th Street corridor in Washington, Beaufort County by upgrading the roadway from a four-lane undivided facility with no multimodal accommodations to a four-lane raised median-divided facility with breaks for left turns, a 10-foot multi-use path, and a 5-foot sidewalk. In May 2025, the Mid-East RPO Technical Coordinating Committee (TCC) and Transportation Advisory Committee (TAC) voted unanimously to adopt a letter of support for U-5860). Right-of-way is currently set to begin this October.

Along with the aforementioned projects, the Mid-East RPO completed Prioritization 7.0, began preparations for Prioritization 8.0, and also provided staff support for the Albemarle RPO between January and June 2025. Additionally, the Mid-East RPO maintained coordination with NCDOT and other planning organizations on various projects and initiatives, and provided transportation-related information to local governments and the public.

On behalf of the Technical Coordinating Committee and Transportation Advisory, I thank the North Carolina Department of Transportation for its continued support of and investment in the Mid-East Rural Planning Organization.

II-2.1: Project Prioritization - \$21,986.34

The following Prioritization 7.0 tasks were completed by staff: Analyzed P7.0 Statewide Mobility, Regional Impact, and Division Needs quantitative scores; held Regional Impact local input point (LIP) meetings with Beaufort County, Martin County, Pitt County, NCDOT Division 1, and NCDOT Division 2; Calculated "local input point scores" for all projects competing in the Regional Impact category; Developed draft Regional Impact local input point assignments in compliance with the Mid-East RPO's P7.0 LIP assignment methodology; Presented draft Regional Impact LIP assignments at 8-1-2024 TCC-TAC meeting; Submitted the TAC-adopted Regional Impact LIP assignments into SPOT Online; Reviewed and analyzed P7.0 Regional Impact total scores; Held Division Needs LIP meetings with Beaufort County, Martin County, Pitt County, NCDOT Division 1, and NCDOT Division 2; Calculated "local input point scores" for all projects competing in the Division Needs category; Developed draft Division Needs LIP assignments in compliance with the Mid-East RPO's P7.0 LIP assignment methodology; Presented draft Division Needs LIP assignments at 11-7-2024 TCC-TAC meeting; Submitted the TAC-adopted Division Needs LIP assignments into SPOT Online. Staff met individually with officials from Beaufort County, Martin County, Pitt County, NCDOT Division 1, and NCDOT Division 2 to discuss priority rankings for committed STIP projects within the Mid-East RPO region. Staff ranked the priority of committed STIP projects based off input from the aforementioned officials, and presented the rankings at the 8-1-2024 joint meeting of the TCC & TAC. Following its adoption by the TCC & TAC at this meeting, staff submitted the rankings to the NCDOT STIP Unit.

CORRECTIONS - \$68.22

The Mid-East Commission was overcharged \$68.22 for an office supply order in Q1 FY 2025. This amount was credited back to the Mid-East Commission; however, \$68.22 was included in the *RPO-2025-1* invoice in error. \$68.22 has been deducted from the total amount eligible for reimbursement in the *RPO-2025-4* invoice.

NOTE:

Due to an RPO staff vacancy within the Albemarle Commission, the Mid-East Commission provided staffing support for the Albemarle Rural Planning Organization in Q3 FY 2025 and Q4 FY 2025. Pursuant to a Memorandum of Understanding signed on January 27, 2025 between the Mid-East Commission and Albemarle Commission, one-half (50%) of all RPO expenses incurred by the Mid-East Commission during this period were billed to the Albemarle Commission. Expenses billed to the Albemarle Commission were then charged to the Albemarle RPO's Planning Work Program (PWP).
